

**WGAL/Reichart's Camping Center/Rockwood "Camper Giveaway"  
Sweepstakes  
Official Rules**

**1. NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER.** The WGAL/Reichart's Camping Center/Rockwood "Camper Giveaway" (the "Sweepstakes") is open to U.S. legal residents who are 18 years of age or older as of date of entry. Void wherever prohibited by law. Sweepstakes begins 12:00pm on August 23, 2011, and ends at 5:00pm on September 18, 2011 (the "Term"). For purposes of these Official Rules, all times are Eastern Standard Times [EST].

**2. HOW TO ENTER:** Register at the show or send post card to: CAMPER CONTEST, P.O. BOX 7127, Lancaster, PA 17604. Deadline for mail entries: Friday, September 16, 2011.

Individuals may also enter at the Pennsylvania RV & Camping Association's 43<sup>rd</sup> Annual RV & Camping Show at the Hersheypark Entertainment Complex, Hershey, Pennsylvania September 14 - 18, 2011 at all entrances, plus at the unit display and sponsor display.

**LIMIT: ONE ENTRY PER PERSON, MAILING ADDRESS OR E-MAIL ADDRESS. (REGARDLESS OF WHETHER MORE THAN ONE PERSON USES THE SAME MAILING OR E-MAIL ADDRESS).** Entrants need only enter once to be eligible.

**3. CHANGE OF ADDRESS POLICY:** It is the sole responsibility of the entrant to notify Sponsor if the entrant changes his or her mailing or e-mail address. In the event of a dispute regarding the identity of the person submitting an online entry, the entry will be deemed to be submitted by the person in whose name the e-mail account is registered.
